- II. Approval of the minutes from February 8, 2019; motioned to be approved, seconded and carried
- III. TEC Membership
 - A. TEC representatives
 - 1. Please review items that should be shared at faculty meetings.
- IV. TEC Committee Reports
 - A. Assessment/Accreditation (Joe Zawicki and Julie Henry)
 - 1. Buffalo State Education System (BSES)
 - 2. Data share for continuous improvement Focus on recruitment and edTPA scores
 - a. Topic ability to achieve licensing requirements
 - b. Focus on:
 - i. EdTPA pass rates
 - Best attempt scores shared
 - New cut scores are lower
 - Pass rates are higher
 - Pass rates by cohorts are going up as well
 - Greater pass rates for those who submitted earlier
 - Julie pointed out that it is important to encourage students to submit edTPA early
 - Aside: Tiffany added a prompt in TaskStream to contact Patty for vouchers to help those who might not be submitting due to money
 - Additional data were shared on # of submissions / year. Percentages ranged from 48%-58% per year; these numbers were fairly consistent across programs; discussion was had about these percentages; these numbers do not reflect those who used safety nets; Patty explained that in the Fall of 2018 she noticed many (more than usual) people completed edTPA and not the other exams

- Data on edTPA submissions by cohort were shared; 3 month submissions going up; later submissions going down; Judy noted that data showing how many took the test would be helpful
- Peter Loehr suggested, after the discussion, that students be encouraged to take the exam during the two vacation weeks during the spring
- ii. TEACH account certification information
 - Surveys
 - 60% have at least 1 certification, 25% have no TEACH account, 15% have no certification in teaching
 - Program level snapshots are on program sites under data share
 - Wendy noted that there are some SUNY colleges that have 100% of their students compliant with certification (ex. Cortland)
 - Wendy called for a taskforce to address certification rates
 - Rosemary shared ideas about adjusting the calendar to promote edTPA compliance; Judy also identified time in January
 - Executive committee will reach out to members to form the aforementioned taskforce
- iii. Recruitment
 - Reviewed CAEP requirements
 - Plans and goals for recruitment
 - Recruiting from a range of backgrounds / increase diversity
 - Recruit for hard to staff schools
 - Recruit for diverse populations served
 - STEM data was shared; showing decrease in graduation rates
 - Discussion in diversity; CAEP and InTASC define diversity in a similar manner; SUNY has a similar definition with the additions of veteran status and world view; BSC has diversity as priority; TEC level has diversity embedded in RISE as an expectation
 - There is no recruitment plan in place in TEU; looking to develop; goal to revitalize full TEC Recruitment Committee (adding retention too); working with admission office for focused/targeted campus visits for education
 - Shannon shared the need to recruit high quality candidates and recruit from diverse backgrounds; a form was shared for TEU members to complete and share ideas
 - Shannon shared the Custom Guide button on the Buffalo State website as a helpful tool for students; yet not data is updated; admissions pulled data from websites; David Loretto said that if changes or updates needed to be made to contact David to communicate those needs: https://buffalostate.customviewbook.com/wizard/?src=2

- V. Unit Head Report
 - A. Holocaust and genocide studies are limited in schools as less Holocaust survivors are alive. BSC has partnered with the Holocaust Museum; Sophia Veffer, survivor, will be participating in Sophia's Legacy which will be a 3 day event in the summer; goal to teach our students tolerance; students and administrators will be participating.
- VI. Certification Office Update (Patty Recchio)
 - A. Patty is preparing to take the two student teachers to Siena for their experience abroad (completing graduate research in 690); Wendy thanked Patty for completing this experience as it is above and beyond her responsibilities in the teacher certification office
- VII. CEURE/Educational Pipeline Initiatives (Diantha Watts)
 - A. After school program
 - 1. At International School 45 (141 Hoyt St.); Pre-K-8; 146 student participants; although over 1100 students in school; Keisha Brandy site coordinator; 7 classroom teachers; 23 tutors; 8 education majors; 1 speech-language major; students are paid \$11/hour to start
 - 2. Schedule starting at 3:30: Homework, ELA or Math, Dinner, ELA or Math, dismissal at 5:45
 - 3. Noted that 584,000 children are left alone, unsupervised after-school in NYS; these are hours where children are most at risk
 - Funding from 21st Century Community Learning Centers (CCLC) 5 year grant; additional funding from M&T Bank; seeking additional funding for sustainability
 - 5. Summer camp will be completed in Caudell Hall
 - 6. Curriculum LitART LEARN; tutors can pick up lessons and teach; everything is scripted; curriculum is engaging and holds attention; Susanna Schenk form BPS provided training for teacher and students
 - 7. Curriculum for Math; Crazy 8s Math Club; program designed to decrease math anxiety; no paper pencil; just discussion then activity; this program is free
 - 8. GoBike buffalo; take bike apart and put it back together; then ride bike home
 - 9. Social Emotional Learning; pay for a full-time social worker who is with these children during the day (provides support during the day and after school); two

social work interns from BSC come; social emotional development curriculum utilized

- 10. Ideas presented for more collaboration with school of education and student teachers; also opportunities for research are available; additionally, service learning, observation students, visitors, edTPA practice, and PTO family night supporters are welcome
- 11. Future objectives would be to increase enrollment; create new partnerships, increase literacy and math achievement, increase school day attendance, decrease negative student behaviors and suspension
