 - A. Assessment/Accreditation (Shannon Budin)
 - Graduation Rates
 - 1. Slide shared of 4-5 year graduation rate for undergraduates who started in TEU
 - 2. Questions posed, "What do you notice about the TEU's 4-year grad rates compared to BSC's 5-year grad rates? What might happen in the next year? Do the TEU graduation rates seem low compared to your personal experience?"
 - Tiffany noted that the data analysis is being worked on
 - Wendy noted that our students who come in as Teacher Ed. students, and then transfer, need to be aggregated in the data
 - Julie pointed out that the students in the TEU appear to have better completer stats than those entering other majors
 - Full time, first time student data is being reported
 - Race/Ethnicity Data
 - Looking at the last 3 years, the majority of the students are of white ethnicity
 - Question posed, "what do you notice about the 3- year trend of racial/ethnic makeup across all TEU programs (initial/advanced levels)?"
 - Grad rate and ethnicity data; white students finish, graduating at a higher percentage than non-white; good discussion was had about why students leave and tracking for why students leave; Julie indicated that there are new surveys that may help improve data collection in this area
 - Shannon and Steve M. shared a graph showing the change in demographics in Buffalo NY (1940-2010) as a point of information
