- III. Lightning Round: COIL for Buffalo State Speech-Language Pathology and Universidad San Pablo Neurology presented by Dr. Anita Senthinathan, Assistant Professor of SLP – LINK to SLIDES
 - a. Speech and movement disorders initiated in 2022; first course in 2023 and last spring 2024; inter-disciplinary groups --> Neuro-Science from Spain and Buff State Grad students in SLP
 - b. Importance of being able to rely on one another (between SLP and Neuro-Science). The clinical cases were based on realistic patients and the cases were created to require the collaboration between the two programs. Cultural components were also included to highlight the international partnership.
 - c. Students co-developed presentations with an overview of the case, diagnosis discussion, and team management approaches.
 - d. Peers had an opportunity to provide feedback and evaluations related to working collaboratively in the group.
 - e. An IRB has been submitted to continue research. Currently collecting data from each cohort regarding cultural intelligence via survey and questionnaire.

- f. Dr. Senthinathan discussed how integrating a problem-based project was helpful in integrating a COIL project into an already full class.
- g. Shannon Budin asked a few clarifying questions about how to get involved with COIL. Brandon Kawa will oversee the COIL program with his new role on January 1, 2025.



According to the New York State Education Department (NYSED), traditional, active registered teacher education programs "shall include at least 100 clock hours of field experiences related to coursework prior to student teaching...At least 15 of the 100 clock hours of field experience shall include a focus on understanding the needs of students with disabilities". During this course, at least 35 field experience hours must be logged by each candidate. Hours which include focus on understanding students with disabilities should be clearly annotated 15 hours out of 100 total field experience hours; link to program requirements).

- Buffalo State University Policy: Admission of Persons with Prior Felony Convictions
 All teacher education programs include a clinical/field component. If you have been convicted of a felony, your criminal history record may impede your ability to complete this program and/or become a NYS certified teacher. Please review Buffalo State's Admission of Persons with Prior Felony Convictions Policy. Effective beginning in the spring 2018 semester, no SUNY campuses may include questions regarding criminal history on admissions applications. However, admitted students who are seeking campus housing; clinical, field experiences, or internships; and study abroad programs will be required to disclose whether they have been convicted of a felony as part of the application process for those programs/services.
