  - 1. The group gathered feedback from faculty and teacher candidates who have taken the new teacher certification exams
  - 2. Meeting with John D'Gati later this month about the concerns raised
- VI. <u>Unit Head update</u> (Wendy Paterson and Kevin Railey reporting)
  - A. Admissions updates please be sure to share this information with your TECU colleagues
    - 1. Thank you to TEU faculty for making the changes required by SUNY
    - 2. Catalog copy been has been adjusted
    - 3. Necessary safety net has been embedded in the process
    - 4. Wendy Paterson has met with Admissions staff to encourage looking at potential teacher candidates holistically when reviewing applications (students will have one year to complete the SAT)
    - 5. Undergraduate Initial programs can complete an "Exemption Form" if a viable candidate applies but doesn't meet current admissions criteria (note: no finite number of possible exemptions)

- 6. Post-bac candidates can also be exempted on a case-by-case basis (note: Post-bac students aren't considered "graduate students" but instead "5<sup>th</sup> year undergraduates.")
- 7. Initial certification no longer required for graduate admissions because candidates are taking longer to get certified due to edTPA and the new certification exams (Patty Recchio suggested changing the wording to "Have you completed an undergraduate teacher preparation program?")
- 8. Make sure your graduate and post-bac students are in Degree Works where seminars are listed
- **9.** We are no longer able to use the pre-major for graduate students because of financial aid concerns. These students should start in the Multidisciplinary Program. (Federal guidelines don't allow a pre-major.) They can be advised by the program they desire and then transfer into the desired program after 6 credits.
- **10.** Procedure change the application to "education/multidisciplinary"
